## **REF: ORDINANCE 11, 1984**

ORDINANCE AMENDING SECTION 4, PARAGRAPH (C) AND SECTION 5 OF ORDINANCE NO. 54, 1974, AND ORDINANCE RESTRICTING AND CONTROLLING HOME SALES CONDUCTED ON THE RESIDENCE PREMISES KNOWN AS GARAGE SALES, PATIO SALES, YARD SALES, CARPORT SALES, BASEMENT SALES, PORCH SALES, DRIVEWAY SALES, AND THE LIKE AS WELL AS PROVIDING PENALTIES FOR VIOLATION THEREOF IN THE CITY OF NORWOOD, OHIO.

## **PROHIBITIONS:**

- 1. NO HOME SALE SHALL BE CONDUCTED BY THE SAME RESIDENT OR MEMBER OF HIS OR HER FAMILY AND/OR THE SAME RESIDENTIAL PROPERTY MORE THAN TWICE IN A TWELVE (12) MONTH PERIOD.
- 2. NO HOME SALE SHALL LAST MORE THAN TWO (2) CONSECUTIVE DAYS AND NO EVENT SHALL BE COMMENCED EARLIER THAN 9:00 A.M. NOR SHALL LAST LATER THAN 8:00 P.M.
- 3. NO HOME SALE SHALL BE CONDUCTED ON A SUNDAY OR LEGAL HOLIDAY.
- 4. NO HOME SALE SHALL OFFER ANY MERCHANDISE FOR SALE THAT HAS BEEN PURCHASED BY THE RESIDENT FOR THE PURPOSE OF RE-SALE AT SUCH HOME SALE. ANY NEW MERCHANDISE OFFERED FOR SALE SHALL BE PRIMA-FACIE EVIDENCE AS MERCHANDISE PURCHASED BY THE RESIDENT FOR RE-SALE AT SUCH HOME SALE.
- 5. NO RESIDENT SHALL POST MORE THAN ONE (1) SIGN PER STREET FRONT ON THE LOT ON WHICH THE SALE IS LOCATED. SUCH HOME SALE SIGN SHALL BE FURNISHED BY THE CITY OF NORWOOD, OHIO UPON PAYMENT OF THE FEES PROVIDED HEREIN. NO OTHER SIGNS SHALL BE PERMITTED TO BE ERECTED OR MAINTAINED IN ANY SUCH RESIDENTIAL ZONING DISTRICT.
- 6. EVERY PERSON SHALL OFFER, SELL OR OTHERWISE STORE ANY MERCHANDISE FOR SALE IN THE REAR OF THE PREMISES WHERE SUCH HOME SALE IS LOCATED, AND NO MERCHANDISE SHALL BE OFFERED, SOLD OR OTHERWISE OFFERED FOR SALE FROM THE FRONT OR SIDE OF THE LOT UPON WHICH THE HOME SALE IS CONDUCTED OR FROM THE FRONT PORCH OF SUCH HOME.

## DISPLAYED AND PENALTIES:

- 1. THE CITY AUDITOR SHALL CHARGE THE APPLICANT A FEE OF TEN DOLLARS (\$10.00).
- 2. EVERY LICENSEE CONDUCTING A HOME SALE SHALL KEEP POSTED IN A PROMINENT PLACE UPON THE LICENSED PREMISES, THE PERMIT CERTIFICATE, AND SHALL EXHIBIT SAME UPON REQUEST.
- 3. WHOEVER VIOLATES OR FAILS TO COMPLY WITH ANY PROVISIONS OF THE ABOVE (ORDINANCE), SHALL BE GUILTY OF A MISDEMEANOR .
